Status of Malaria in the W.H.O. Region of Europe

ABSTRACT

Background: The objective of this paper is to present a birds-eye view of the Malaria situation in the World Health Organization (W.H.O.) Region of Europe. Methods: The study design included online searches related to Malaria for each country such as from W.H.O. and United Nations documents. Results: Fifty-one countries (Albania, Andorra, Armenia, Austria, Azerbaijan, Belarus, Belgium, Bosnia & Herzegovina, Bulgaria, Croatia, Cyprus, Czechia, Denmark, Estonia, France, Finland, Germany, Greece, Hungary, Iceland, Ireland, Israel, Italy, Kazakhstan, Kyrgyzstan, Latvia, Lithuania, Luxembourg, Malta, Monaco, Montenegro, Netherlands, North Macedonia, Norway, Poland, Portugal, Republic of Moldova, Romania, Russian Federation, San Marino, Serbia, Slovakia, Slovenia, Spain, Sweden, Switzerland, Tajikistan, Turkmenistan, Ukraine, United Kingdom of Great Britain & Northern Ireland and Uzbekistan) have been certified by the W.H.O. to be free from indigenous Malaria. Two countries (Georgia and Turkey) are yet to apply to the W.H.O. for certification of elimination of Malaria. Conclusions: Two countries in the W.H.O. Region of Europe are yet to receive certification of Malaria elimination.

Region of Europe consists of the following fifty-three countries (Figure 1): Albania, Andorra, Armenia, Austria, Azerbaijan, Belarus, Belgium, Bosnia & Herzegovina, Bulgaria, Croatia, Cyprus, Czechia, Denmark, Estonia, France, Finland, Georgia, Germany, Greece, Hungary, Iceland, Ireland, Israel, Italy, Kazakhstan, Kyrgyzstan, Latvia, Lithuania, Luxembourg, Malta, Monaco, Montenegro, Netherlands, North Macedonia, Norway, Poland, Portugal, Republic of Moldova, Romania, Russian Federation, San Marino, Serbia, Slovakia, Slovenia, Spain, Sweden, Switzerland, Tajikistan, Turkey, Turkmenistan, Ukraine, United Kingdom of Great Britain & Northern Ireland and Uzbekistan.

- 4. **Austria:** Austria was certified by the W.H.O. to be free from Malaria in 1963.[2]
- 5. **Azerbaijan:** Azerbaijan was certified by the W.H.O. to be free from Malaria in 2023.[7]
- 6. **Belarus:** Belarus was certified to be free from Malaria by the W.H.O. in 2012. [2]
- 7. **Belgium:** Belgium was certified by the W.H.O. to be free from Malaria in 1963.[2]

- 8. **Bosnia and Herzegovina:** Bosnia and Herzegovina were certified by the W.H.O. to be free from Malaria in 1973. [2]

- 17. **Georgia:** In Georgia, transmission of Plasmodium vivax Malaria was interrupted in 2010. Two imported cases were detected in 2011 and 2012. No locally acquired cases were reported in 2013. The country is now in the "prevention of Malaria reintroduction" phase. [4]
- 18. **Germany:** Germany was certified by the W.H.O. to be free of Malaria in 1964. [2]
- 19. **Greece:** Greece was certified by the W.H.O. to be free of Malaria in 2012. [2]
- 20. **Hungary:** Hungary was certified by the W.H.O. to be free of Malaria in 1964. [2]
- 21. **Iceland:** Iceland was certified by the W.H.O. to be free of Malaria in 1963. [2]
- 22. **Ireland:** Ireland was certified by the W.H.O. to be free of Malaria in 1963. [2]
- 23. **Israel:** Israel was certified by the W.H.O. to be free of Malaria in 2012. [2]
- 24. **Italy:** Italy was certified by the W.H.O. to be free of Malaria in 1970. [2]
- 25. **Kazakhstan:** Kazakhstan was certified by the W.H.O. to be free of Malaria in 2012. [2]
- 26. **Kyrgyzstan:** Kyrgyzstan was certified by the W.H.O. to be free of Malaria in 2016. [2]

- 52. **United Kingdom of Great Britain & Northern Ireland:** The United Kingdom of Great Britain & Northern Ireland was certified to be free from Malaria by the W.H.O. in 1963.[2]
- 53. **Uzbekistan:** Uzbekistan was certified to be free from Malaria by the W.H.O. in 2018.[2]
